To all who may be thinking about attending the CRNG "Season Finale Shoot":

On August 16th, 2009 a seven year old boy named John James Venner was stuck and killed by an automobile while walking with his brothers to the store on Rte 102 in Chester about a 10th of a mile from Gun Club Road.

"JJ" lived with his parents and brothers at 86 Gun Club Road about a hundred yards from the CRNG front gate. They are our neighbors and the family and "JJ" was very familiar to many members of CRNG.

Needless to say the total membership of CRNG is devastated by this terrible tragedy and the horrific loss the Venner family has suffered.

CHESTER – A walk to the neighborhood store turned deadly for a 7-year-old boy who died after being struck by a pick-up truck Saturday.

State police would not release the boy's name, but residents yesterday identified him as John-James "JJ" Venner, who lived nearby at 86 Rod and Gun Club Road.

Venner, his 10-year-old brother and a friend, 11, were walking against traffic in the eastbound breakdown lane when Venner was struck by an eastbound pick-up truck, police said. The boy was closest to the travel lane of the two-lane state highway, also known as Route 102.

"
