"Planned Parenthood in Manchester had some visitors Wednesday, June 6, 2007" reported Betty Breuder, Vice President of NH Right to Life.

"I understand that 20 or so, Jr. High students from Park Side and South Side Schools were escorted through a group of prolife witnesses, to the Promiscuity Promoters at Planned Parenthood on Penacook St. there in Manchester. They were inside about a half hour or longer. Most wore bright blue tie dye shirts -- one identified as Park side, another young girl said she was from South side. (Girls and Boys) There were one male chaperone with 'Staff' on his shirt and one or two female adults" remarks Darlene Marie Pawlik, President of NH Right to Life.

"The students were told not to talk to the Right to Life people, and they would not accept literature from me when I tried to give them some truthful information. However; they came out with Planned Parenthood literature" Mrs. Breuder continued.

Former Representative Kathy Souza, who was there at the time with NHRTL Vice President Betty Breuder and Jeannie Szulc, called Mayor Guinta from the scene on Betty's cell phone, but he was home sick. "Mayor Guinta called me back and left a message that this was inappropriate behavior and he thought we wouldn't see this happen again" stated Mrs. Souza yesterday.

"Planned Parenthood on Penacook Street is now committing surgical abortions. They have two abortionists. They lure the young girls in to fuel the baby killing business" said Mrs. Breuder, "PP exploits teens by promoting promiscuity leading to the need for STD testing, birth control and abortion (the very lucrative baby killing/mother wounding industry). This is a circular business plan. PP's business relies heavily on the uninformed, vulnerable youth to make lots and lots of money. They give/sell birth control to students and children without any accountability every day. Some of the children have reported being very 'sick' from the alteration in their hormone levels because of the 'pills'."

"I am very concerned about this. As a parent and as a tax paying citizen, I want an explanation. Was this a school field trip? (It was during school hours, just after 11am)," asks Mrs. Pawlik. "Doesn't the school district have a 'no soliciting' policy? Surely, you would agree this IS solicitation, even active promotion of a business that specifically targets teens and children for its business. "Planned Parenthood covers up sexual predators who abuse children. See <http://www.childpredators.com/>", She insisted.

"PP is also the prime plaintiff, along with others in the abortion industry, in the injunction against the Parental Notification Act of 2003. The law that would have mandated the notification (not consent) of at least one parent before an abortion could be committed on a minor child. They are also the driving force behind the Repeal of Parental Notification that is now before the Senate," reminds Julie Laughner.

"Are you happy with the Manchester School District cooperating with the usurpation of parental rights by delivering Manchester's children into the hands of Planned Parenthood, the Promiscuity Promoters?" asks Darlene Pawlik, "if not, let them know. Call the school board, the superintendent and the principals of South Side and Park Side Schools. Call your Representatives and Senators too and ask, 'Why are our tax dollars being used to take our children to Planned Parenthood, the promiscuity promoters?'"
